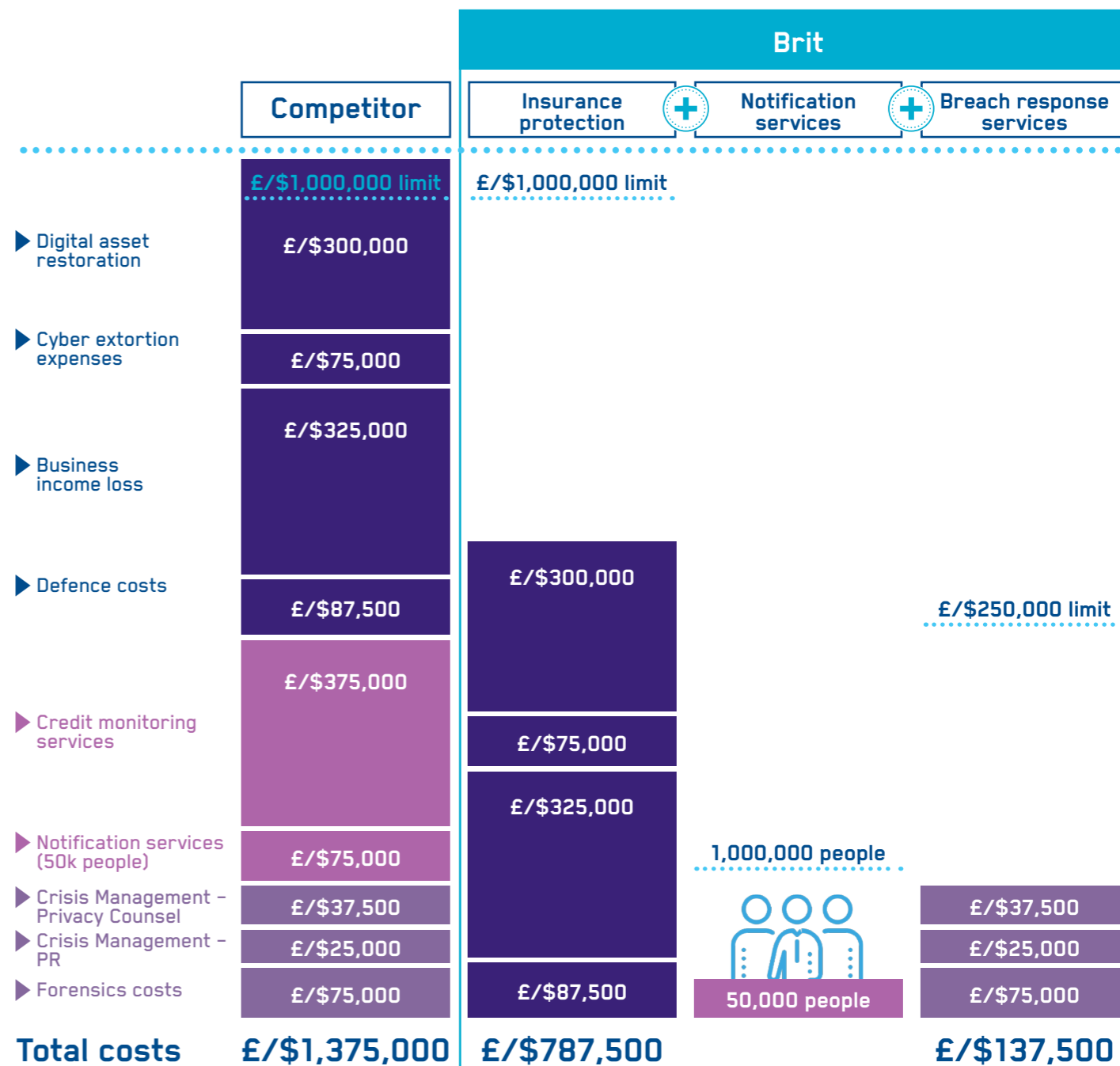


How our cover performs
