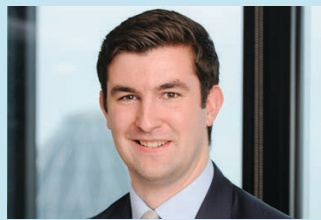
Our risk management service also provides online training for staff, including phishing simulations and a virtual CISO service to support the insured's CISO or IT Security team.

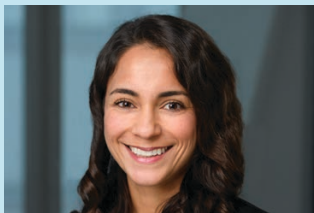
